

# BGMPS Financial Contract

I understand that if I do not meet the requirements for this contract, the following will take place:

If I am delinquent with my tuition and have not made arrangements with the administration

1. My child will not be allowed to participate in any extracurricular activities to include sports, cheerleading, and club meetings until such time as the account is paid and current.
2. My child will not be allowed to take semester exams until financial obligations are paid and current.
3. My child may be removed from class until financial obligations for student(s) tuition have been paid and the account is current.

\_\_\_\_ If my account is 1 month past due, I understand that I **will lose my tuition assistance** and I will need to pay full tuition **for the rest of the school year**. In addition the administration may request that the student withdraw from the school.

\_\_\_\_ If I should withdraw my child or if the school withdraws my child, no paper work, withdrawal forms or student records will be released until all financial obligations have been met.

\_\_\_\_ If I owe any money to an outstanding Catholic or Private school my child will not be considered for enrolled for the school year until I have paid that balance owed to that school.

\_\_\_\_ I understand that as a private school, Bishop Garriga Middle Preparatory School's budget is based mostly on tuition and contributions. Therefore, in the event of withdrawal or dismissal of my child, I am obligated to pay any outstanding tuition, fees and fundraising through the end of the month that my child last attended classes.

*By signing this contract, I authorize the school to release information regarding past due tuition accounts along with other necessary records which are requested by any public and/or private school, local credit bureau, collection agency, or any school official, employee or agent who has legitimate educational or legal interest in the information.*

*I agree to support and follow all policies, terms, and conditions, in the BGMPS Parent-Student Handbook and Diocesan procedures.*

*I HAVE READ AND UNDERSTAND MY (OUR) FINANCIAL OBLIGATIONS TO BISHOP GARRIGA MIDDLE PREPARATORY SCHOOL, AND BY INITIALING THE ABOVE STATEMENTS AND SIGNING THIS CONTRACT, I FULLY AGREE TO THE CONDITIONS AND I AM COMMITTED TO FULFILL THESE RESPONSIBILITIES AS A PARENT/GUARDIAN OF THE STUDENT(S) NAMED IN THIS CONTRACT. NOTE: Registration and the signing of this contract does not guarantee official enrollment in the fall semester of 2017. Official enrollment is to be determined in the fall, providing all of the school's criteria has been met, which can be dependent upon the student's grades at the end of the spring semester in 2017; a tuition account paid in full and not in arrears for the 2016-2017 academic year; or serious misconduct by the student between the date the contract is signed and the end of the 2017 spring semester, or consideration of any other extenuating factors as determined by the Principal. Note: Regarding student withdrawal, tuition will be charged for the full month that the withdrawal date falls in, regardless of the withdrawal date.*
